

Statements required in notice if the proposed tax rate exceeds the no-new-revenue tax rate and the voter-approval tax rate but does not exceed the de minimis rate, as prescribed by Tax Code §§26.06(b-1) and 26.063(c).

NOTICE OF PUBLIC HEARING ON TAX INCREASE

This notice only applies only to a taxing unit other than a special taxing unit or municipality with a population of less than 30,000, regardless of whether it is a special taxing unit.

A tax rate of \$ 0.10 per \$100 valuation has been proposed by the governing body of Caldwell / Hays Emergency Services District No. 1 ("CHESD No. 1").

PROPOSED TAX RATE	\$0.1000 per \$100
NO-NEW-REVENUE TAX RATE	\$0.0799 per \$100
VOTER-APPROVAL TAX RATE	\$0.0831 per \$100
DE MINIMIS RATE	\$0.1055 per \$100

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for Caldwell / Hays Emergency Services District No. 1 from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that Caldwell / Hays Emergency Services District No. 1 may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for Caldwell / Hays Emergency Services District No. 1 exceeds the voter approval rate for Caldwell / Hays Emergency Services District No. 1.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for Caldwell / Hays Emergency Services District No. 1, the rate that will raise \$500,000, and the current debt rate for CHESD No. 1.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that CHESD No. 1 is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON AUGUST 14, 2023 at 8809 Niederwald Strasse, Kyle, Texas 78640.

The proposed tax rate is greater than the voter-approval tax rate but not greater than the de minimis rate. However, the proposed tax rate exceeds the rate that allows voters to petition for an election under Section 26.075, Tax Code.

If CHESD No. 1 adopts the proposed tax rate, the qualified voters of the CHESD No. 1 may petition the CHESD No. 1 to require an election to be held to determine whether to reduce the proposed tax rate. If a majority of the voters reject the proposed tax rate, the tax rate of the CHESD No. 1 will be the voter-approval tax rate of the CHESD No. 1.

YOUR TAXES OWED UNDER ANY OF THE TAX RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state. The following table compares the taxes imposed on the average residence homestead by CHESD No. 1 last year to the taxes proposed to be imposed on the average residence homestead by CHESD No. 1 this year.

Average homestead taxable value	\$197,391	\$229,885	Increase of 16.46174%
Tax on average homestead	\$197.39	\$229.89	Increase of \$32.50or 16.46487%
Total tax levy on all properties	\$1,492,328.57	\$1,980,739.87	Increase of \$488,411.30 or 32.72813%
